Thomas More College is controlled and directed by The Thomas More Trust which provides for the appointment of a maximum of 16 Trustees. Trustees are elected for a term of 5 years, renewed by 5 years at the discretion of the Board.

The Trustees are selected by recommendations from within sub-committees, the broader parent body or community, or they are Exco members from the College.

THE MAIN FUNCTIONS OF THE BOARD ARE AS FOLLOWS:

1. To develop short, medium and long-term strategies which include the core elements of education, culture and sport;
2. To uphold and protect the Christian Ethos which is the Pole Star of the College;
3. To ensure that the Mission Statement works in harmony with the Ethos;
4. To advise and give guidance to the Executive Members of the College;
5. To ensure the financial sustainability of the College;
6. To ensure that fiduciary duties are complied with, governance is exemplary and that all stakeholders are treated fairly.

In order to uphold all of the above functions, it is necessary to establish various sub committees which appropriate Trustees chair. The Board meets at least five times a year, however, the Chairman, the Vice Chairman and Treasurer meet with the Heads and the Business Manager on a regular basis to give advice and guidance when required.

The Board is appropriately structured and well balanced. This along with the breadth and depth of dealing issues that the subcommittee approach allows, assists greatly with the achievement of our goals and objectives.

I trust that this brief summary has given you a better understanding of the functions of the Board of Trustees, and I would like to take this opportunity to thank all Trustees for giving up their time and expertise to support Thomas More College.

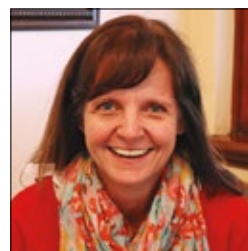

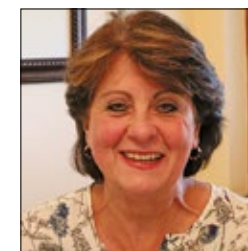
